## Happy New Year!

There is always something to look forward to with the start of a new year. We are hitting the ground running in 2018. We will be breaking ground on the Broadband Project starting from our Laurens substation. We will also be placing our communications shelters at our Laurens, Oaksville, and Richfield substations on January 11, 2018. This Broadband project will provide a direct benefit to our members and the community. We are looking at April, 2018 to start adding services.



In 2017, we gathered GPS data for over two-thirds of our system. Our data collection is going well and we should have our entire system finished by the middle of 2018. We still have the Towns of Cherry Valley, Middlefield, Springfield, and Westford to complete. This data collection is helping us get our system maps up to date and more accurate, allowing us to determine our pole attachments. This information will help us with outage restoration and planning for new services. Because we are doing it ourselves, it's helping us control the cost of the project.


We are continuing to emphasize right-of-way maintenance in 2018. We have to address more of the higher canopy trimming in order to minimize costly outages. Tree growth was very rapid in 2017. In January and February, we will be trimming trees in the Towns of Laurens and Otsego.

We are trying to control costs in many ways by working more efficiently, leveraging technology, and consolidating job duties. We have several financial hurdles to overcome. We pay a lot in property taxes and many of our other costs continue to rise while our sales of electricity has been staying about the same for several years. We added 75 new services in 2017 which is helpful and we see this as a positive trend. This is 35 more services than we added in 2016. We are constantly looking at ways to grow the cooperative and to operate more efficiently.

We will be focusing more on economic development in 2018. Rural life offers many positives like low crime, open spaces, diverse recreation, clean air and water and relatively low taxes. We believe we need to do a better job of promoting these benefits to attract and retain more people.

We are looking forward to the New Year, so, how do we serve you better in 2018? The same way many of us try to serve our families and our communities each day—by listening to you, our members, in our offices, on telephones, through social media exchanges and in our face-to-face meetings. We are always ready to listen so please contact us when you want to talk. When you have questions about energy efficiency, electrical service or any of our products or services, just ask us. ## Idle Service Fees

The Board of Directors adopted a policy change regarding seasonal meter disconnects. The policy change was made to allocate fixed costs more fairly to all members who benefit from operations when they need them. If the cooperative disconnects a meter, there will continue to be a \$25.66 monthly Idle Service Fee as long as the cooperative-owned equipment (meter, transformer, etc.) remains on site. The fee stops when the equipment is fully removed at your request. If you have an inactive service and you don't plan on reconnecting it, please contact us so we can make arrangements to retire it. We will be sending out letters in early 2018 to locations with inactive services reminding members that as long as there is cooperative equipment there, an idle service monthly fee of \$25.66 will be charged until the equipment is retired.

## Space Heater Safety

Did you know 32% of home heating fires are caused by space heaters? Follow these tips if you're using a space heater to warm things up:

- Don't leave your space heater unattended. Always unplug before you leave the house or go to bed.
- Don't use an extension cord to plug in your space heater. It can cause the heater to overheat and can be a tripping hazard.
- Don't place a space heater near furniture, curtains, clothing or bedding.
- Buy a unit with an automatic shutoff in case it tips over.
